Tacolized Taco Bar Service Unit Specifications and Requirements:

In order to reserve your event date and time, we must receive a credit/debit card payment. If payment is not received, your date will be subject to cancellation.

Tacolized Taco Bar Service on site, made-to-order, taco bar service unit is a self-contained “mobile restaurant” allowing us to prepare tacos as each customer orders. Standard condiments include, Tacolized Red Salsa, Tacolized Green Salsa, onions, cilantro, limes, forks, plates, and napkins are included in each package. Additional side orders are available upon request.

Site Selection:

Tacolized Taco Bar Service reserves the right to pre-approve the location of the event and may require the opportunity to inspect the site. Tacolized Taco Bar Service carts require a firm, level surface for the cart (4ft x 6ft clear space is required). Tacolized Taco Bar Service maintains the right to relocate the cart if the site is unacceptable or unsafe. Common sense prevails. Tacolized Taco Bar Service, Mobile Taco Carts are fully self contained and require no outside assistance or power outlets.

1. Costs and Requirements

A. Minimum Event Charge:

The Minimum Charge is the following; 20 people or \$400, whichever is greater.

B. Service Time:

For parties of 45 people or less, Tacolized Taco Bar Service has found 1-1/2 hours of service time to be sufficient. However, arrangements can be made if this does not work. For parties over 50 people, we have a standard serve time of 2 hours. If additional serving time is needed, please speak with your Event Coordinator. Event will be assessed an hourly rate for every hour after 2 hours upon agreement. The serve time does not include setup and breakdown. Service time is based on your total order, any changes to your order may also affect your service time.

C. Travel Charge:

A travel/mileage charge will be assessed depending on the location of the event. All such charges shall be noted in the quote/invoice. Tacolized Taco Bar Service does its best to ensure prompt service, professional and attentive staff who will do their best to accommodate your needs. However, if a cook/driver is late due to unforeseen traffic, road hazards, or other force majeure, you will be contacted.

D. Required Communication:

Customer will have received required information prior to event from Tacolized Taco Bar Service, i.e, Cooks Name, Estimated time of arrival etc.

E. Required Space:

Our custom designed and manufactured carts, are designed to fit through any standard 36 inch door way. Please have a clear passage to the area for safe service.

Note: The ONLY change allowed 5 days prior to event date is an INCREASE in the headcount and menu selection. NO DECREASES IN HEADCOUNT OR MENU are allowed.

2. Terms of payment:

Bookings & Event Confirmation: A \$200.00 or 20%, (whichever is greater) payment is required upon booking event. Booking Payments are non-refundable after 3 Days from receiving 1st booking payment to receive FULL refund. Any cancellations must be made within 3 Days from receiving 1st booking payment to receive FULL refund.

A. The receipt of your Booking payment by Tacolized Taco Bar Service will confirm the reservation of your event. The payment will be applied to the total charges for the taco bar service.

B. Balance Due:

Final payment must be made prior to the event, by check, or any Major Credit or Debit Card. Cash will not be accepted unless prior arrangements have been made. Cook(s) will NOT have final invoice or accept Cash Payment on hand.

3. Promotional materials:

The use of the Tacolized Taco Bar Service name is available for use on printed materials and or electronic advertising; radio, television, etc, upon discussion. The artwork for all printed materials, (posters, tickets or other promotional materials) using the Tacolized Taco Bar Service name, logos, trademarks or graphics ("Names and Marks") will be provided by Tacolized Taco Bar Service. 4. Changes in terms of agreement:

If customer desires to change the date, time, location or menu of the event as originally agreed to in the invoice, the customer must inform Tacolized Taco Bar Service of such change no later than five (5) days prior to the scheduled date of the event. Tacolized Taco Bar Service is unable to make any changes to the event if such notification is less than 5 days prior to the event time.

5. Insurance and indemnification requirements:

If special insurance requirements are needed by Tacolized Taco Bar Service to the client/park/venue, etc., please provide such/all information at least two weeks prior for proper handling, etc. Except through its own gross negligence, bad faith, or intentional misconduct, Tacolized Taco Bar Service does not assume liability for any damages or loss whatsoever. Customer agrees that Tacolized Taco Bar Service and its employees and/or agents shall not be liable to the Customer for any claims, liabilities, or expenses relating to the taco cart catering event.

6. Right to rescind:

Tacolized Taco Bar Service reserves the right, at any time, to unilaterally rescind this Agreement and, or to deny service, even after event has commenced, if any event is not conducted (or any personnel related to the event does not conduct themselves) in a manner consistent with the law and abiding with Tacolized Taco Bar Service Mission Statement or image of a family run business.

7. Force Majeur:

The parties to this Agreement will be excused from the performance of this Agreement in whole or in part if the performance by Tacolized Taco Bar Service or Customer of any of its material obligations under this Agreement is prevented by operation of law or any cause beyond the reasonable control of such party, including without limitation fire, flood, disruption of transportation (but not the failure of a party to reasonably anticipate possible transportation delays), earthquake, public disaster, strike, labor dispute or unrest, accident, breakdown of electrical or other equipment, riot, war, insurrection, civil unrest, Act of God, any act of any legal or governmental authority (all of which causes are referred to as "events of force majeure"). If the event is cancelled or curtailed because of the occurrence of any of the foregoing events of force majeure, Tacolized Taco Bar Service shall remit the full booking payment, less any out-of-pocket costs incurred by Tacolized Taco Bar Service in connection with the cancelled or curtailed event.
